Frasier, Law Enforcement Sector Representative: Expertise within MPD is impaired driving and drugged driving enforcement. Worked on preemptive city ordinance for the City and helping the coalition find ways for the coalition to be prepared when policy does change.</li> <li>○ Esmerelda, Government Sector Representative: Our program is part of the ID National Guard, working with LE and Substance Abuse Prevention groups. She tries to partner in any way she can to help share connections in the prevention world.</li> <li>○ Mary Liz, Faith Sector Representative: Working with local churches to see if MADC can present at different religious functions. It's a continuation of what Mary Liz has already been doing. She helped organize the Legislative Update and was the Media representative.</li> <li>○ Howard Davis, Business Sector Representative: Several events with youth, conducting over 350 youth based events for the community. Each event has a safety focus. Working with Habitat for Humanity to build a youth organization. Howard enjoys working with the kids and helps get donations for the youth based programming he works on. Majority of her clients are federal inmates and on probation.
